## **URGENT ACTION**

#### **BEFORE YOU START**

Urgent Actions (UAs) are issued when there is an **URGENT NEED FOR INTERVENTION** to stop human rights violations or abuses against an individual or group and **MASS MOBILISATION** is the most strategic campaign tool to achieve the objective. Therefore, consider whether:

- ✓ It's urgent: are appeals needed within the next few days or weeks?
- ✓ It's **simple**: do the text and the appeals briefly encapsulate the necessary details?
- ✓ A mass response is needed: is it appropriate to be issued as a public document, and for the UA network to take action?

#### APPROVAL PROCESS

- 1. ORIGINATOR (+ team) ← IAR CAMPAIGNER
- 3. ORIGINATOR [v3] ← FINAL APPROVER
- 4. ORIGINATOR [final] IAR CAMPAIGNER who will upload to the IAR Platform, to the web site and distribute to the UA Network.

Note: steps 1-3 may require the document to go back and forth several times depending on the required edits and comments, however it will always go back to the originator before being sent to the next reviewer. Therefore, please be clear at all times what stage of review the UA is at, and who has already approved it.

Date: 12 August 2025

This case has already been prosecuted by the prosecutor's office and submitted to the court. According to reliable sources, the trial is scheduled for mid-August.

Previously, the prosecutor had attempted to negotiate a guilty plea with Gao, proposing a three-year sentence. However, under current Chinese law, the maximum statutory sentence for this charge is three years of imprisonment. In practice, sentences are usually less than a year and do not exceed three years. Gao rejected the offer, believing the sentence was too severe.

His wife and young child have also been subjected to severe restrictions. Gao's wife is banned from leaving the country under the pretext of "national security," though no formal charges have been filed.

Their 7-year-old son, a U.S. citizen, is technically allowed to leave the country but is unable to do so without his mother. He was supposed to return to the U.S. to start school. In effect, he is also being held.

In this case, international attention could potentially result in 1) the public prosecutor withdrawing the charges against him (though the likelihood is low at present), but could potentially reduce his sentencing; and 2) prompt Chinese authorities to lift the travel restrictions on Gao's family, allowing them to return to the US.

#### **OBJECTIVES:**

- His immediate and unconditional release Pending his release, that
- Gao Zhen has regular, unrestricted access to family and his lawyers, and is not subject to torture or other ill-treatment.
- Authorities end the harassment of and threats towards his family and lift the travel restrictions on them and ensure that they can enter and leave China freely.

TARGETS AND THEIR POWER TO ALLEVIATE THE VIOLATIONS: The primary target is the Director of the Sanhe Branch of the Langfang Public Security Bureau, because:

- 1. He can drop the charges against Gao Zhen
- He oversees the management of the detention centre where Zhang is currently being held. Thus, he has the authority to grant Gao's access to her family, a lawyer of his choice, and adequate health care.

#### SYSTEMIC AIM:

Through Gao Zhen's case we want to raise awareness of and publicly condemn the use of laws such as the Heroes and Martyrs Protection Law as a tool to suppress the artistic and intellectual

expression of Chinese artists. In so doing, we hope to defend the freedom of artistic and other expression in China and prevent political censorship from further stifling creative expression. **DURATION:** This UA will run until 30 Dec 2025, because, this case may have a verdict by the end of the year. The China Team will separately work with Amnesty EIO and the International Advocacy Team (IAT) to press for the inclusion of Gao Zhen's case in the regular EU "Item 4" statement at the UNHRC, where human rights issues and detained individuals in China are, as a rule, mentioned.

# **URGENT ACTION**

#### ARTIST DETAINED FOR ONE YEAR WITHOUT TRIAL

Chinese artist and US permanent resident Gao Zhen was first detained in August 2024 for "slandering heroes and martyrs." According to reports, his trial is expected in mid-August 2025. His wife and child, who travelled with him to China, have also a *de facto* travel ban since his arrest. No artist or individual should be punished solely for their creative work or for expressing their personal views; Chinese authorities must release Gao Zhen immediately and unconditionally, and lift all extra-legal restrictions on his wife and child, allowing them to leave the country freely and safely.

Dear Secretary Ma,

I am writing to express my grave concern for artist **Gao Zhen** (高幾), who has been detained at Sanhe City Detention Center on charges of 'slandering China's heroes and martyrs' (侵害英雄烈士名譽榮譽罪) for almost one year without trial.

Date: 12 August 2025

His case has been submitted to the court by the prosecutor's office, but regret that these charges are wholly baseless; Gao has merely exercised his right to freedom. I fear that Gao Zhen's case reflects the ongoing criminalization of freedom of artistic expression and creation using vague charges such as 'slandering China's heroes and martyrs'. Restricting forms of expression with the only interest of protecting the 'honour' or reputation of public officials, institutions, symbols or flags exceeds what is allowed under international law.

My distress is heightened by concerns that Gao's wife and young son have been banned from leaving the country, purportedly under the pretext of "national security," though no formal charges have been filed or documentation provided to justify these measures. As a result, the 7-year-old boy has been unable to continue his education for a full school year.

This case is a clear example of the Chinese authorities using political censorship to stifle creative expression. No artist or individual should be punished solely for their creative work or for expressing their personal views.

#### I urge you to:

- Immediately and unconditionally release Gao Zhen;
- Pending his release, ensure that Gao's right to communicate with his family is fully respected and protected, and he is not subject to torture or other ill-treatment;
- Stop harassing and threatening his family and lallow them to leave the country freely and safely;

#### **ADDITIONAL INFORMATION**

Gao Zhen, 69 years old, is a prominent artist in contemporary Chinese art and a member of the renowned Gao Brothers duo. On 26 August 2024, Gao was detained while traveling in China with his wife and son. Around 30 police officers raided his studio in Yanjiao, a town in Sanhe City, Hebei province. The authorities photographed his artworks, confiscated and sealed several sculptures – m st of which were created over a decade ago—before sealing the studio.

Date: 12 August 2025

The following day, Gao's wife was informed by the Sanhe City Public Security Bureau of his detention. He has since been held at the Sanhe City Detention Center on charges of "slandering China's heroes and martyrs," a crime punishable by up to three years in prison. Reliable sources report that this case has already been processed by the prosecutor's office and submitted to the court and the trial is scheduled for mid-August.

In addition, from early May to late July 2025, Gao's family has been unable to receive any correspondence from him. This suggests that his legally protected right to communicate with his family has been unjustly restricted or denied.

His wife and young child have also suffered. Gao's wife is banned from leaving the country under the pretext of "national security," though no formal charges have been filed. Their 7-year-old son, a U.S. citizen, has the legal right to leave the country but is in practice unable to do so without being accompanied, ideally by his parents. The de facto travel ban has kept him out of school for a full year.

Since the 1980s, the Gao Brothers have employed satirical humor to shed light on the atrocities of the Cultural Revolution, consistently challenging the limits of social commentary. Their work offers a sharp critique of the Cultural Revolution and former Chinese leader Mao Zedong, exposing the extent of the authoritarian practices employed during Mao's regime. These subjects remain deeply sensitive and taboo in contemporary China.
